**Declaration of a State of Local Emergency
Seven (7) Extension
September 6, 2024 – September 12, 2024**

Whereas: an emergency exists within the First Nation of the Sturgeon Lake Cree Nation due to Wildfire on the Sturgeon Lake Cree Nation Indian Reserves of 154, 154A and 154B where a mandatory evacuation occurred for all residents with in the above-mentioned reserves on May 5, 2023; and

Whereas: our First Nation has exceeded all resources and therefore notify Indigenous Services Canada (ISC) and the Province of Alberta that continued additional support may be required to assist our Community; and

Whereas: the Chief and Council understand policies and provisions for compensation and some costs will be the responsibility of the First Nation and Council will ensure documentation and records are available for recovery assessment; and

Whereas: this notice may be terminated at any time by the Chief and Council, or after seven (7) days the notice will automatically expire. If necessary, this notice will be renewed every seven (7) days until the event is over; and

Therefore be it Resolved That:

Chief and Council extend the State of Local Emergency for the Sturgeon Lake Cree Nation.


